1: Number of Teams & Groups:

- 24 Teams / 4 Groups (6 Teams Each)

2: Team Registration:

- By **7:10 am**, all teams are requested to register themselves with **Mr. PADHU** & collect the Tournament T-Shirts
- Collect from **Mr. RAMESH KRISHNAN** - Free YONEX Lucky Draw - Sponsored by **MISTER KEEN**

3: Draw Lot:

- Teams per Group - Lot will be drawn **BY 7:15 am** in front of all Participants
- Team info - 8 Mavericks / 2 India Club / 2 Sky Warriors
2 Laguna City Shuttlers / 2 Lohas Lions / 2 KCC / 2 Hung Hom Shuttlers
1 South Horizons / 1 Malayalam Academy HK / 1 Tung Chung Tigers
1 Tung Chung
- Lot will be drawn in such a way that - if there are more than 1 team from a particular Club, the teams will be split & slotted in different group. For Example: Mavericks 8 teams will be split into 4 groups to have 2 teams under each group A,B,C,D.

4: Game Schedule:

- Warm up time from 7:00 am to 7:29 am
- First game will start exactly at **7:30 am.**
- Players are expected to play **BACK-TO-BACK** games depending on the schedule. During Best of 3 games, one game to another game, time gap will be only **1 TO 2 MINUTES**
- Please refer detailed game schedule on separate attachment
- Once the draw lot is done, please pay attention to the schedule.
- If the Player(s) are not available **WITHIN 2 MINS** from the scheduled game time - it will be considered as walk over

5: Round Robin Criteria:

- Hard stop at **21 POINTS. NO DEUCE**
- Single Game Format (21 Points) (Side Change at 11 Points)
 - Against each opponent, A team which secures a **WIN** will be awarded **1 POINT**
 - Losing Team will be awarded **0 POINT**
 - 4 Teams from Each Group, with maximum number of Points, will advance to R16
- In Case of Tie of Points, below will be observed
 - Score difference per game will be calculated. For Example: Score: 21-16. The Winner Gets +5 and the Loser gets -5
 - The Team with maximum total in Score Difference advances
 - In case of tie on difference of scores, Head-to-Head will be considered. Team that won that match will supercede
 - In case of tie on difference of scores & also tie on Head-to-Head - the difference of scores within the tied up teams will be calculated and the team with maximum score will advance
- The Group order will be decided basis
 - The number of Matches won
 - In case of Tie of the matches won, above will be followed to determine the placing of the teams

6: R16 / Quarter-Finals / Semi-Finals & Finals (All Best of 3 Format)

- 15 Points Game. **DEUCE ALLOWED (DIFFERENTIAL OF 2 POINTS)**
- R16 / QF & SF will be Knock Out basis
- Best of 3 Format (15 Points)

- Against each opponent, A team which secures 2 out of 3 game wins - will be declared **WINNER** of the Match & will proceed to next Stage
- A team winning 2 Games consecutively, the 3rd game will be not required
- 1st Set and 2nd Set - No Side Change. 3rd Set Side Change at 8th Point
